BLAST FROM THE PAST



The following article was taken from Paw Prints, January 2004 issue written by Jeff Swedran:

BUMPERS – IS THERE A RIGHT ONE?

Are you getting ready to start field training or are you planning on restocking your missing or damaged bumpers? Are you perusing the dog catalogs or window-shopping at your local dog supply store for replacements? Lots to choose from. Small ones, large ones, colored ones, plastic ones and canvas ones. Still confused? Excerpts from THE RETRIEVER JOURNAL article by Butch Goodwin may help you with your final selection.

Butch points out that for the value, plastic bumpers are the best buy. The major advantage of plastic bumpers is their availability in assorted colors. White is the most popular color for training while orange is used for handling experienced dogs to blind retrieves. Plastic bumpers come in two sizes, 2"x12" and 3"x12" (there may be an inch or so difference in the length or diameter, depending on the manufacturer). Cleaning is a snap by just hosing bumpers off after a training session. The large white bumpers are excellent for teaching basic lining and handling as the dog can immediately see the bumpers when cast to the pile.

Another advantage of plastic bumpers is that they have significant weight behind them so they will land in your target area and are least affected by light breezes. You will need a bunch of bumpers to start with so you may as well look for a deal where you can start off with at least a dozen.

The downside of plastic bumpers can be inconsistency in how firm or how soft they are, even from the same order from the company. This results in varied weights of each bumper, which leads to inconsistent throws. Dogs tend to squeeze or roll the softer ones, especially on long water retrieves. If the bumper develops cracks, it tends to "breathe", encouraging the dog to squeeze or roll the bumper on retrieve.

Canvas bumpers have their advantage in field training. They feel much more comfortable in a dog's mouth on the retrieve. Also, canvas holds its own shape and consistency in cold weather where plastic bumpers tend to get hard. Canvas bumpers hold scent better. All the better when training in the snow or in tall grass where the dog has to use his nose. A major disadvantage to canvas is that when it gets dirty, you can never really clean it up. Canvas bumpers are also lighter than plastic ones, which will affect the distance that it is thrown. Wind also has a greater effect on the canvas ones.

As you can see from the article, both canvas and plastic have their advantages. A good mix of small and large plastic bumpers and a few canvas ones are probably a good mix when selecting training equipment but don't forget the most important secret from the pro trainers. Birds. Live birds, dead birds. Ducks, pigeons, chukkars. Dead birds can be wrapped in newspaper after they are dry and stored in plastic bags and placed in the freezer for future use.

MWFCRC AWARD APPLICATION

MWFCRC Award Information and Application

The main purpose of the Midwest Waterways Flat-Coated Retriever Club is to educate and encourage members to participate in activities that promote our breed. Each club member will have different goals for themselves and their dogs but achievements deserve special recognition. The awards committee created a unique acknowledgement for members who complete the requirements for each accomplishment. The awards are attainable for all levels of participation including new members as well as novice and seasoned competitors. The awards are as follows:

New Horizons – for those members who title their dog in a venue that is new to the owner/handler. The title is to include any title presented by any governing body including Canine Good Citizen (CGC) and Therapy Dog International (TDI- with 20 hours of visitations in a 6 month period). The intent of this award is to offer recognition to those who try something new with their dog. The award will be a wine-type bottle full of dog treats and with a label reflecting the accomplishment.

Golden Whistle – for the first advanced field title earned by a member to include SH and HR (UKC) and including advanced titles earned immediately following the inception of this award. The award is to encourage and recognize those members who are doing what our dogs are bred to do: hunt and retrieve. The award will be a gold-colored whistle presented in a velvet lined wooden box with the achievement reflected in the lid of the box. The award will be presented to owner/handlers or amateurs handling someone else's dog but not to professional handlers handling a dog he/she has trained professionally for another person.

MWFCRC Enthusiasm Award – awarded to any member who attends all club sponsored events during the year including but not limited to any supported entries, seminars, field days and WC/WCX. The award shall be a fleece throw blanket with an embroidered MWFCRC logo. This award can be earned only once per member.

WC/WCX Award - duck bands awarded to any member passing a WC/WCX test regardless of the host club.

Awards for the previous year will be presented at the current year's annual meeting. No awards will be mailed.
